We are also asking for 10 Year Business Tax Exemption at 100% of taxable value.



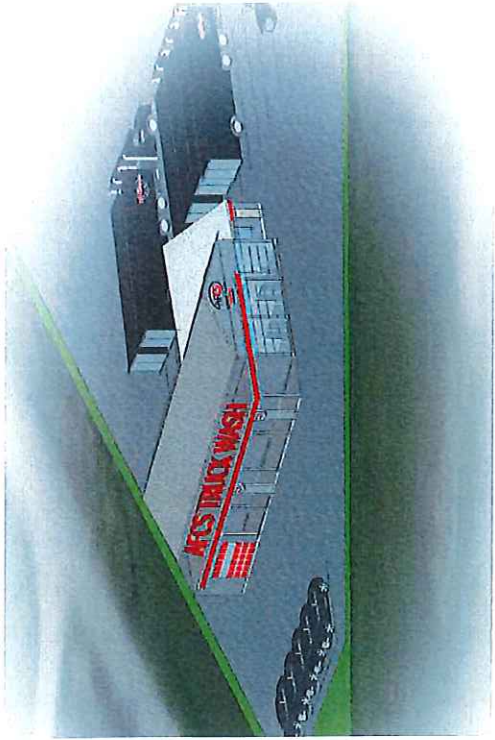
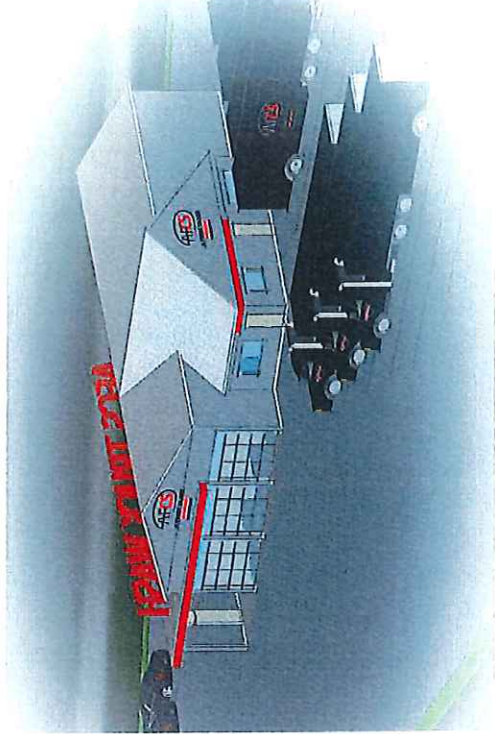
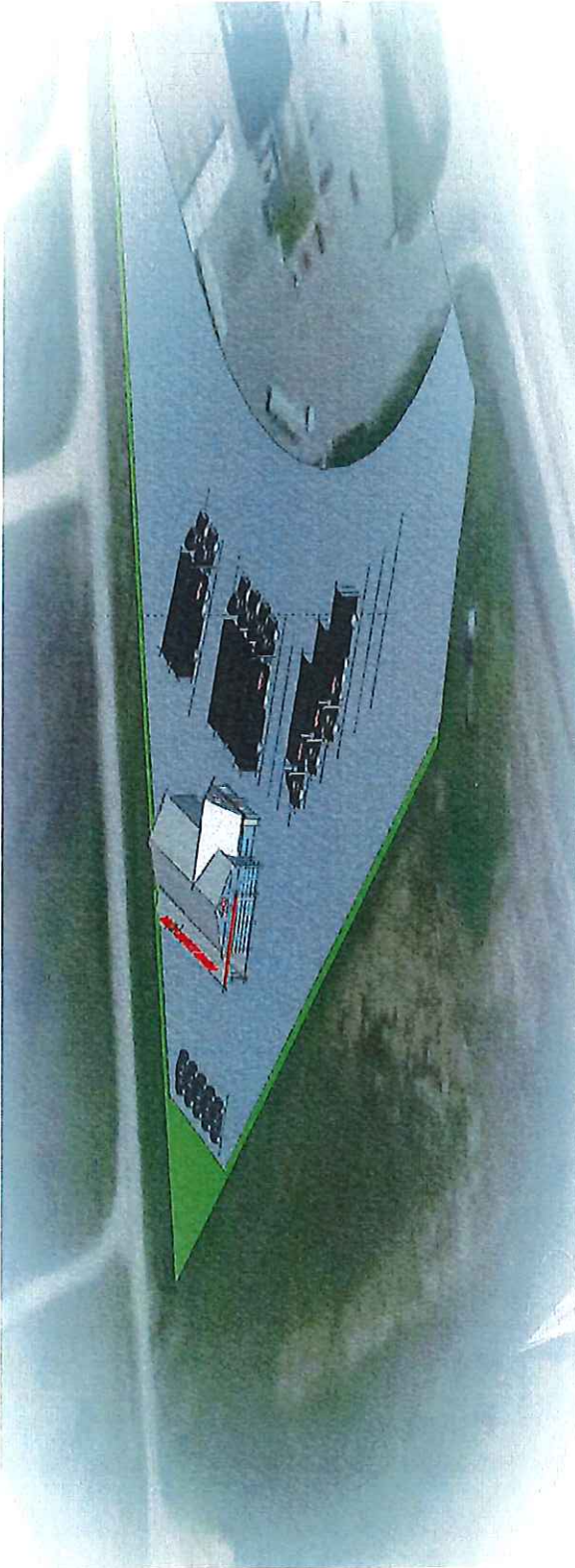
