

RIVERSIDE CITY COUNCIL MEETING: September 17, 2018

The Riverside City Council meeting opened at 6:30 pm in City Hall with Mayor Allen Schneider requesting roll call. Council members present were: Andy Rodgers, Tom Sexton, Bob Schneider Jr., Jeanine Redlinger, and Ralph Schnoebelen.

Motion by Schnoebelen to approve the agenda, Second by Redlinger, passed 5-0.

Schneider moved to approve the minutes from September 4th, and the expenditures pulling Schnoebelen Inc. invoice for separate vote. Second by Rodgers, passed 5-0. Schneider moved to pay Schnoebelen Inc. invoice in the amount of \$62.83. Second by Redlinger, passed 4-0. Schnoebelen abstained.

Kathy Lindhorst addressed Council about "no passing zone" on Hwy 22 through downtown.

Schnoebelen moved to appoint Edgar McGuire to the Planning and Zoning Committee to fill vacancy until December, 2020. Second by Redlinger, passed 5-0.

Redlinger moved to open Public Hearing for the Northern Heights development agreement at 6:42 pm. Second by Schneider, passed 5-0.

Chris Kirkwood gave her opinion, against the development agreement, to the Council. There were no other written or oral responses. Schneider moved to close Public Hearing at 6:47 pm. Second by Schnoebelen, passed 5-0.

Steve Schmidt, APEX development Group, and Scott Pottorff, MMS Consultants answered Council questions on the agreement.

Redlinger moved to pass Resolution 091718-01; Northern Growth Development Agreement with APEX Development Group, LLC, pending Attorney approval. Second by Schneider, passed 4-1. Sexton opposed.

Schneider moved to place signage on Hwy 22 for Schnoebelen Street, with placement not to block visibility, and acceptable with Iowa DOT. Second by Schnoebelen, passed 5-0.

Deputy Clerk position was offered to Heather Cornett, with a wage of \$16.00 per hour, starting October 1, 2018.

Scott Pottorff, MMS Consultants gave updates on Capital Projects.

Schneider moved to pass Resolution 091718-02; Approving Pay Request #6 for J&L Construction, LLC in the amount of \$312,177.27 for the Downtown Streetscape Project. Second by Redlinger, passed 5-0.

Schnoebelen moved to pass Resolution 091718-03; Approving Change Order #11 in the amount of \$4281.07 for J&L Construction, LLC for extra work required to make water connections in the Downtown Streetscape project. Second by Rodgers, passed 5-0.

Sexton moved to pass Resolution 091718-04; Approving Easement Agreement with Mark and Carla Lyons for a permanent easement for storm sewer in the Downtown Streetscape project for the sum of \$1.00. Second by Redlinger, passed 5-0.

Schnoebelen moved to pass Resolution 091718-05; Approving Easement Agreement with Hoard's Bakery, LLC for a permanent easement for storm sewer in the Downtown Streetscape project for the sum of \$1.00. Second by Rodgers, passed 5-0.

Sexton moved to pass Resolution 091718-06; Approving Easement Agreement with Kevin and Barbara Kiene for a permanent easement for storm sewer in the Downtown Streetscape project for the sum of \$1.00. Second by Rodgers, passed 5-0.

Redlinger moved to pass Resolution 091718-07; Approving Easement Agreement with The Church in Riverside for a permanent easement for storm sewer in the Downtown Streetscape project for the sum of \$1.00. Second by Schneider, passed 5-0.

Schnoebelen moved to pass Resolution 091718-08; Approving Easement Agreement with Jerry Murphy for a permanent easement for storm sewer in the Downtown Streetscape project for the sum of \$1.00. Second by Schneider, passed 5-0.

Sexton moved to open the Public Hearing for approving the final plat for Galileo Drive at 8:08 pm. Second by Rodgers, passed 5-0.

There were no written or oral comments. Sexton moved to close Public Hearing at 8:09 pm. Second by Schnoebelen, passed 5-0.

Schnoebelen moved to pass Resolution 091718-09; Accept Final Plat for Galileo Drive. Second by Schneider, passed 5-0.

Schneider moved to pass Resolution 091718-10; Setting Date for Public Hearing to Rezone TWRVR Property at 111 Knisel Street, from R2 to R3, at the City Council meeting on October 1st, 2018, which begins at 6:30 pm. Second by Rodgers, passed 5-0.

Bill Stukey, PeopleService, Inc. gave the August water and waste water report.

Schneider moved to purchase replacement tires for the skid loader from B&B Automotive for \$760.00 plus disposal fee. Second by Schnoebelen, passed 5-0.

Clerk reported on Nuisance Abatement progress.

Council discussed the Iowa Economic Development Authority "Walk Around" which will be Tuesday, September 25th. They will meet at 10 am with City leaders, and then report back to the public at 2 pm in City Chambers. Public is welcome to attend.

Mayor Schneider presented "Council Priorities Summary" to help in setting goals for future Council meetings.

Schnoebelen moved to send City Clerk to the IMFOA Fall Conference in October. Second by Redlinger, passed 5-0.

Schnoebelen moved to adjourn at 9:06 pm. Second by Redlinger, passed 5-0.
