Redlinger moved to adjourn at 6:24 pm. Second by Rodgers, passed 5-0



Total calls – 22 calls for service in December

RFD responded to a mix of calls for the month, the call volume continues to be steady and increasing. **RFD responded to 231 incidents for 2020**, that was up from 2019 (216). We also had slow months in March and April due to the start of COVID. If those would have been normal month's we would have probably finished 2020 around 250-260 calls.

Training:

The members trained on ice rescue and cold water emergencies. This included the members getting into the water with our ice rescue suits and performing Go Rescues on other members.

RESA:

The members completed the RFD community shirt sales fundraiser, that brought in \$900. The members also sold all 100 calendars to raise another \$2000 for RESA. The members have done an excellent job of getting creative with fundraisers this year, raising around \$11,000 for RESA to help with yearly operating costs/projects.

Other News

The progress on the new truck continues, the slideout is being built, the topper gets installed in January. The truck will be in service late February. The Chief is getting things ready for budget planning. We are currently looking for new members, we had 6 members retire over 2020. The longest serving member of RFD Bill Halleran retired with 45 years of dedication and service to the community. This will be a huge loss to RFD as Bill served as FF/EMT and over his years was the Fire Chief and Training Officer. RFD will start 2021 with 31 members of those members 8 have State of Iowa EMS certification.

O & M Report: December 2020

Water Operation & Maintenance

- All first stage membranes were installed with the assistance of Rhino Industries. PeopleService Assistant Region Manager Heath Dreager and Region Manager Steve Robbinette also assisted with installation. Some of the membranes on the first stage were heavily fouled with iron deposits and were likely the cause of increased pump demands. Consolidated Water offered to collect the old membranes to recondition for other uses. They have offered in exchange to trade us for some cleaning chemicals. This has saved several hundred dollars in landfill fees for disposal of the old membranes.
- Christine and I met with Brett DeWolfe to further discuss a sewer meter and City water rates.
- 15 locates and 1 emergency locate all complete.
- 7 door postings and 2 disconnects.
- Ben and I helped Bryan and Jay plow and haul snow over a few days during the snowstorms.

Wastewater Operation & Maintenance

- On 12-5-2020 while doing rounds I noticed the flow readings were abnormal at the wastewater plant. I went to check lift station 1 to see if there was an issue and I found the pump was continuously running. The cause was from a float being stuck and not allowing the pump to cycle off. The result was the pump air locking and not being able to prime itself. I called Electric Pump and they came to lift the pump up to release the air. We also adjusted the float to prevent it from getting stuck in the future. We don't have the capabilities to lift the pump ourselves.

- On 12-24-2020 lift station 2 called at 10 PM for a low temp alarm. I placed the VFD's in bypass and ran the pumps on direct drive until the following Monday when temperatures warmed up.
- On 12-25-2020 I was called for a low level alarm at lift station 5. I found the transducer was not reading. I cleaned the transducer, but it is still not functioning. The station is running on back up floats until a new transducer arrives.

COVID-19 vaccine Q&A

Has Public Health received the vaccine?

- Yes – the first shipment arrived on 12/22/20

Has Public Health started vaccinating people?

- Yes – we have started vaccinating those individuals in the 1A priority group.

Is Public Health vaccinating the long-term care residents?

- No – those residents and workers are being vaccinated through Pharmacy agreements and not by Public Health.

When can I be vaccinated?

- The recommendations are set by the Federal government based on availability of vaccine and clinical trial outcomes
- WCPH does not have control over priority groups
- Phase 1A will include long-term care residents, long-term care workers and healthcare workers with direct patient care
 - WCPH will have direct contact with local providers to schedule vaccinations

When will new priority groups be established?

- As more vaccine becomes available, the priority groups will be opened up by the State
- The recommendations are set by the Federal government based on availability of vaccine and clinical trial outcomes
- WCPH does not have control over priority groups

Will there be additional phases of vaccine rollout?

- Yes
 - Phase 1B is anticipated to include frontline workers (fire, law enforcement, day care providers, schools) and populations of individuals that are 75 years of age and older
 - Phase 1C is anticipated to include additional essential workers, individuals aged 65-74 and those aged 18-74 with high risk medical conditions
- Priority group criteria is established by the Federal government and may change
- WCPH does not have control over priority groups

I do not fall into any of the priority groups. When can I be vaccinated?

- By mid-2021 there should be enough vaccine available for anyone who wants it
- WCPH does not have control over priority groups

I have had COVID. Am I eligible for the vaccine?

- Yes IF you meet the criteria below:
 - You fall into a specified priority group AND

- You are not actively ill (meaning in quarantine, isolation, or showing signs of symptoms)

I have had COVID. Do I need to wait for 90 days to receive the vaccine?

- No – HOWEVER you will need to meet criteria for a specified priority group and check with your physician

Is Public Health the only provider of vaccine in the County?

- Yes, at this time

Do you have a waiting list for the vaccine?

- No
 - As new priority groups become effective, WCPH will communicate who meets the criteria

Where is the most up to date information on the vaccine?

When will our children be vaccinated?

- At this time, Pfizer is approved for individuals 16 years of age and older. Moderna is approved for those 18 years of age. At this time, we don't know when a vaccine will be approved for children.

After I get vaccinated, will I still have to wear a mask/be quarantined after COVID exposure?

- At this time, there will be no change to our current public health recommendations for those who have been vaccinated. We'd still recommend you wear a mask around those not in your household, social distance, and quarantine post-exposure.
