SALE OF CONSUMER FIREWORKS PERMIT APPLICATION

Riverside Code 124.01. Consumer Fireworks. This includes First-Class Consumer Fireworks and Second-Class Consumer Fireworks as those terms are defined in Section 100.19 and Chapter 727 of the Iowa Code.

Riverside Code 124.03.3 It shall be unlawful for a person to use or explode Consumer Fireworks within the City Limits of Riverside, Iowa.

Riverside Code 124.04. Sale of Consumer Fireworks. It shall be unlawful for any person to offer for sale, expose for sale or sell Consumer Fireworks, unless the person is a retailer or community group defined in Chapter 100, Iowa Code, and possess and complies with all requirements of a Consumer Fireworks seller license issued by the State Fire Marshall. In addition, any person shall also possess a permit and proof of insurance from the City of Riverside in order to offer for sale, expose for sale or sell Consumer Fireworks. The cost of said permit shall be set by resolution of the City.

Permit Fee: \$35.00

Riverside Code 124.04.1.B: Consumer Fireworks shall only sold within a temporary structure between the dates of June 13th and July 8th, **124.04.2.A, B:** Zoning Districts C-1, C-2, M-1 and M-21. **124.04.3** Consumer Fireworks may not be sold on public property or within a residential zoning district.

Proof of Insurance: Personal Injury, \$500,000 per person; Property Damage \$500,000; Total exposure \$1,000,000.
