Admin Yancey presented Administrator's report, updates to website, and speed sign reports.

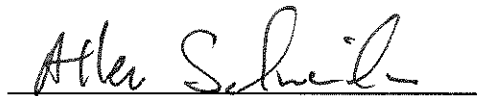
McGuire moved to adjourn at 7:06 pm. Second by Rodgers, passed 5-0.
