

SUBJECT: Riverside, IA Water and Wastewater Treatment Plants – Controls Upgrade

Mr. Smith,

We are pleased to offer the following proposal for the controls upgrade at both your Water and Wastewater Treatment Plants. This upgrade incorporates the latest technology with new communication appliances, PLCs, touchscreen operator interfaces, uninterruptible power supplies (UPS), and secure VPNs for remote access and troubleshooting. These improvements apply to the existing WWTP Main Control Panel, WTP MCC-1 Supervisory Control Panel, and Elevated Storage Tank Control Panel.

We also propose additional instrumentation and networking enhancements, including a gas detection system with warning lights and a temperature transmitter for the Wastewater Treatment Plant, new submersible level transmitters for Wells #7 and #8, and VPN appliances and network racks for the Wastewater and Water Treatment Plants.

The programmable logic controllers (PLC), operator interface, and radios in the Main Control Panel, MCC-1 Supervisory Control Panel, and Elevated Storage Tank Control Panel have been discontinued by Allen-Bradley, along with the associated hardware, are no longer supported, and are beyond the useful operating life. Replacement parts for the existing PLC and HMI are costly, often come with long lead times, and are primarily available in used condition on secondary markets.

The new communication appliances offer the latest technology, providing Ethernet communication for your entire system to replace outdated serial technology. VPN appliances will allow operators to securely connect and control the system at any time from a mobile device or PC and enable faster system support without the cost or delays associated with travel.

Item L: This proposal also includes a new SCADA workstation, which enhances operational visibility, enables interactive trending, provides historical and event data, supports enhanced remote access, custom reporting capabilities, and more. Additionally, we include WIN-911 Interactive alarm-dialing software, which delivers alarm notifications with no limitations on unique alarm channels.







Item P: This option item includes integration of your (5) lift stations into the SCADA network for total transparency and robust alarm notification.

Our proposal includes equipment and services as detailed below.

Wastewater Treatment Plant Controls and Telemetry Upgrade

A One (1) **Existing Main Control Panel modifications**, to include the removal of the existing PLC and HMI with the installation of a new PLC and HMI as detailed below.

Proposed panel modifications shall be complete with the installation of a new Allen-Bradley PanelView Plus 7 Performance 15" Touchscreen, Allen-Bradley CompactLogix Programmable Logic Controller (PLC), I/O cards, UPS, ethernet switch, power supplies, fusing, terminals, and internal panel wiring.

- B One (1) **Gas Detection System**, to include sensors for Methane, Oxygen, and Hydrogen Sulfide with testing and calibration supplies, and red warning light for the exterior of the Headworks building door.
- C One (1) **Temperature Switch,** to include wall-mount temperature transmitter with 4-20mA analog outputs to be installed in Control Room.
- D One (1) **Network Rack**, to include wall-mount network rack unit, rack-mount UPS, and 16-port Power over Ethernet (PoE) switch for use with future security cameras and access control system.
- E One (1) **VPN appliance,** to include Firewall and one year software support and upgrade software license.
